

## SC C6, "Distribution Systems and Dispersed Generation"

### Activity Report

#### Highlights

During the 2006 SC meeting in Paris a new strategic plan, to cover, in agreement with CIGRE practice, the next decade, was agreed. In 2007 the SC pursued the activity following the strategy indicated in the new plan. The plan states some basic guidelines to drive the activity of the SC in the next years:

- ✓ To study the connection and the integration of *Dispersed Energy Resources (DER)*, including small size generators, storage and relevant power electronic devices.
- ✓ To study the application of the DER concept as a part of the medium-long term evolution of distribution systems (Microgrids and Active Distribution Networks).
- ✓ To study actions and processes for demand management and customers involvement,
- ✓ To examine the opportunity to extend the SC activity to study the evolution of distribution networks including subjects that are not strictly related to the application of DG concept.

A number of technical subjects are identified and detailed in the new Strategic plan.

In 2007 a new WG was set up to study the use of storage to support the integration of DER.

## SC Strategic Plan and Action Plan

In the 2006 SC meeting in Paris the 2007-2016 Strategic Plan was finally approved; the plan is now fully in force. The 2007 – 2008 Action Plan indicates the activities to be undertaken under guidance of the new Strategic Plan.

## SC meetings

The SC met on May 2, 2007 in Langkawi, Malaysia, under invitation of the Malaysian National Committee.

In 2009 the SC shall meet in Canada in conjunction with the CIGRE/PES Symposium.

## **SC participation to Regional Meetings and Symposia**

In 2007 the SC participated to the organisation, together with the Malaysian National Committee, of a 2 days Colloquium (May 3 and 4) on “*Electricity for rural socio-economic development*“. The Colloquium was organised with the support of Asia-Oceania Regional Council (AORC-CIGRE), HAPUA (Head of ASEAN Power Utilities and Authorities) and CIRED Malaysia.

In 2009 the SC shall participate to the organisation of the CIGRE/PES Symposium. on “Integration of wide-scale renewable resources into power delivery system” to be held in Calgary (Canada) on July 29 – 31.

## **Relations with other organisation**

Relations with EURELECTRIC, CIRED and IEA are well established through the action of the Chairman and of some members who are also active in those associations; a link is also assured with IEEE Committees and WGs active on topics of interest of the SC by the action of the USA member.

In 2007 the Chairman chaired a round table on “European regulators and the experience of introduced regulations” during the 2007 CIRED Conference.

Three members of the SC are members of the Advisory Council of the European Technology Platform SmartGrids, stated in 2005.
